Serial numbers consist of 9 letters or numbers (without spaces or dashes) and can be found on a label on the device. See below for placement details.

- **D2 Delta series** = The serial number is located on the back of the watch. Serial number prefixes are: D2 Delta S = 5Q4; D2 Delta = 5Q6; D2 Delta PX = 5Q8

- **GDL 5x series** = The serial number is located on the bottom of the device. Serial number prefix is: 4RF (for all units)

- **aera 660** = The serial number is located inside the battery compartment, behind the battery. Serial number prefix is: 4NN

- **VIRB Ultra 30** = The serial number is located inside the battery compartment, behind the battery. Serial number prefix is: 4QR
